Privacy Notice

Trinity Grammar School, Kew (Trinity) is committed to protecting your privacy in accordance with the Australian Privacy Principles.

From time to time, Trinity collects personal information from students, parents, staff, contractors and volunteers. Personal information about individuals will generally be collected by the filling out of forms, face-to-face meetings, interviews, telephone calls and other communications.

The School only collects such personal information as it needs to meet its primary and secondary purposes. Primary purposes include looking after the educational, social and medical wellbeing of students, and discharging the School's duty of care. Secondary purposes include keeping parents/guardians informed through correspondence, newsletters, Trinity Connect, reports and magazines, and seeking donations and marketing for the School.

If Trinity cannot obtain the information referred to above we may not be able to enrol or continue the enrolment of the student, or permit the student to take part in a particular activity.

The School may disclose personal information to another school, government department, medical practitioner, people such as sports coaches providing services to the School, recipients to Trinity publications, parents/guardians (e.g. on the class list) and anyone to whom we are required to disclose information by law.

Resources produced through marketing and donations contribute to the provision of a quality learning environment. Personal information may be disclosed to those who assist with fundraising, such as alumni organisations. You may from time to time receive fundraising information. School publications that contain personal information may be used for marketing purposes. If you do not agree to this please inform the Privacy Officer in writing.
